

LEGAL NOTICE
REQUEST FOR QUALIFICATIONS

The MASSACHUSETTS PORT AUTHORITY (Authority) is soliciting consulting services for MPA CONTRACT NO. **M717 CRANE 3 & 4 TROLLEY RAIL AND FESTOON SYSTEM REPLACEMENT**. The Authority is seeking qualified multidiscipline consulting firm or team, with proven experience to provide professional services including planning, design, bid, and construction related services, including resident inspection, relative to replacement of trolley rail system on both existing ship-to-shore Crane numbers 3 and 4. In addition the festoon (boom and trolley) system of cables will be replaced on both cranes. Additional repairs related to the structural, electrical, and mechanical systems on Massport ship-to-shore Cranes may also be added to this work, if necessary. The Consultant must be able to work closely with the Authority and other interested parties in order to provide such services in a timely and effective manner.

The consultant shall demonstrate experience in several disciplines including but not limited to Low-Profile Ship-to-Shore Crane Design & Operation, Container Port Operations, Structural, Electrical, Mechanical, Waterfront Engineering, Cost Estimating, Utility Design, Construction Phasing, Climate Resiliency, and Sustainable Design.

The contract will be work order based, and Consultant's fee for each work order shall be negotiated; however, the total fee for the contract shall not exceed **\$1,000,000**.
