

The MASSACHUSETTS PORT AUTHORITY (Authority) is soliciting consulting services for **MPA CONTRACT NO. L1711, WOBURN LOGAN EXPRESS SITE IMPROVEMENTS, WOBURN, MASSACHUSETTS.** The Authority is seeking qualified multidiscipline consulting firms or teams, with proven experience to provide licensed site professional and professional engineering services for planning, design, and construction, including resident inspection for pavement rehabilitation and miscellaneous repairs for civil components of the facility. The Consultant must be able to work closely with the Authority and other interested parties in order to provide such services in a timely and effective manner.

The consultant shall demonstrate experience in several disciplines including but not limited to Civil Design using Civil 3D/CIM, Drainage, Environmental Permitting, Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) site construction experience, Site Electrical Engineering, Construction Phasing, Pavement Design and Testing, Cost Estimating, Topographical Survey, LEAN Practices, and Sustainable Design.

The contract will be work order based, and Consultant's fee for each work order shall be negotiated; however, the total fee for each contract shall not exceed **ONE MILLION FIVE HUNDRED THOUSAND DOLLARS** (\$1,500,000).

BACKGROUND:

The Massachusetts Port Authority, as a part of a consortium with the MBTA and MassDOT, are jointly seeking to rehabilitate the pavement at the Anderson Regional Transportation Center (ARTC) located at 100 Atlantic Avenue in Woburn, Massachusetts (Woburn Logan Express). The consortium is responsible for providing ongoing maintenance of the facility. Massachusetts Port Authority will administer the design and construction. The pavement is an Environmental Cap over a Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) site and is required to be kept is a good state of repair. The Grant of Environmental Restitution (GEAR) also requires vegetation maintenance, security fencing maintenance as well as other facilities.

The ARTC facility is located within a portion of the EPA-regulated CERCLA site namely Industri-Plex Site. The consortium controlled area under this project is approximately 16.5 acres in area and was constructed in 2001. The ARTC facility consists of a train (commuter rail) station building, covered loading platforms adjacent to loading areas for ground transportation, and surface parking areas (long term, short term, and daily). The ARTC main building, transportation loading area, and the short-term parking area are located in the central portion of the site. The northern portion of the site includes the commuter rail parking lot, and the southern portion of the site contains the overnight parking area. Several landscaped areas are dispersed throughout the facility but are mostly present near the entrance at the end of Atlantic Avenue. A secondary exit for the facility is located to the northeast, adjacent to the commuter rail parking lot. Massachusetts Bay Transportation Authority (MBTA) railroad tracks border the Site to the west, which can be assessed from the ARTC. The Site is bordered to the east by commercial buildings adjacent to Atlantic Avenue and the remainder of the Site is surrounded by open, vegetated land with a detention basin and other storm water control features.


This project will rehabilitate the pavement to maintain an Environmental Cap consistent with the requirements of the GEAR.

In April 2022, GZA performed an annual cover inspection of the ARTC facility. Inspection activities included overall site review, inspection of drainage structures, and documenting site cover conditions along with areas and/or structures that require continued monitoring and or/maintenance.

Applicable Inspection Reports will be provided separately in its entirety after a consultant has been selected.



SCOPE OF WORK:

The Authority is seeking qualified multidiscipline consulting firms or teams, with proven experience to provide licensed site professional and professional engineering services for planning, design, and construction, including resident inspection for roadway rehabilitation and miscellaneous repairs at the Anderson Regional Transportation Center in Woburn, Massachusetts. The Consultant must be able to work closely with the Authority and other interested parties in order to provide such services in a timely and effective manner.

The consultant shall demonstrate experience in several disciplines including but not limited to: licensed site professional, Civil Design using Civil 3D/CIM, Drainage, Environmental Permitting (as necessary), Site Electrical Engineering, Construction Phasing, Pavement Design and Testing, Construction Cost Estimating, Topographical Survey, LEAN Practices, Resiliency, and Sustainable Design.

The scope of work for each respective project shall include, but not be limited to, the following:

(1) The Consultant must commence work by performing a detailed review of existing conditions, original design documents, record drawings, available reports, and submittals. With this information, the Consultant shall prepare a Preliminary Design Report to define the project scope, establish priorities for the work, prepare budgetary cost, develop the project schedule, and identify logistical concerns.

(2) The Consultant will be expected to assist in any permitting required as part of these changes, in particular with relation to contaminated soils, as appropriate.

(3) The Consultant will be expected to develop different options to present to ARTC board followed by design documents suitable for bidding and construction. This shall include specifications, cost estimates, contract drawings including but not limited to phasing, civil and electrical.

(4) The Consultant will be required to perform Construction Administration services and provide full-time resident inspection services for all aspects of construction. This will include providing multiple inspectors on a daily basis based on construction activities as well as supporting work on weekends and at night, if necessary. Summaries of safety huddles and field reports will need to be provided to the project manager daily.

(5) The Consultant will be required to provide the necessary acceptance testing during construction and manage the closeout of the construction contract. This will include development of punch list items as the work progresses.

(6) The Consultant will also be required to verify compliance of the work through review of the asbuilt documents at project completion.

(7) Construction of the project and pavement rehabilitations will need to be coordinated and phased to minimize impacts to operations of the facility. Construction is likely to take place in one construction season. The Consultant will be required to develop detailed phasing plans for review with internal Massport departments and the facility operator.

The contract will be work order based and the Consultant's fee for each work order shall be negotiated; however, the total fee for each separate project contract shall not exceed \$1,500,000.

EVALUATION CRITERIA:

The submission shall be evaluated on the basis of the following equally weighted criteria:

- (1) Demonstrated experience and knowledge of the team for similar projects of similar size and complexity particularly important to demonstrate for the Project Manager. Demonstrated environmental experience with CERCLA sites and/or grants of environmental restrictions particularly for the licensed site professional. Highlight the experience and expertise for major sub-consultants and their assigned staff. Familiarity with public construction procurement under MGL Ch. 30, and
- (2) Project understanding and proposed technical approach including QA/QC process during document preparation, cost management and scheduling capabilities, construction oversight, ability to plan and perform work with minimal disruption to facility operations, and
- (3) Demonstrated experience in integrating and managing CIM/Civil 3D in the planning, design and construction. Experience of utilizing Lean Design & Construction (Last Planner System®, Scrum or others tools) to increase the reliability and significantly improve projects and teams' performance.
- (4) Demonstrated project experience in sustainable, resilient and infrastructure design and construction, including experience with roadway features and project aspects that reduce environmental impact and measure and report quantifiable results. These may include strategies such as reducing storm water runoff, lifecycle analysis including embodied carbon for materials used as part of the respective project, materials re-use and recycling as part of an overall waste management program and infrastructure sustainability certification schemes relevant to this proposal. Firms are encouraged to demonstrate "outside of the box" thinking for examples of inclusion of sustainable practices into its projects and specify how those practices may be applied to this project proposal. Firms must demonstrate the capability to incorporate design features into any project type that reflect best practices in environmental stewardship, and
- (5) Proposed approach to enhance diversity and inclusion of the project team to increase the pool of consultants working on the Authority's projects. For those M/WBE firms proposed, please describe type and/or category of work (i.e. architecture, structural, Lean, etc.); include the specific roles to be played by the M/WBE and the extent to which such M/WBE involvement is anticipated as of date of the proposal submission, (% goal).

The Authority recommends that each evaluation criteria is addressed in the response as a separate section.

The selection shall involve a two-step process including the shortlisting of a minimum of three firms based on an evaluation of the Statements of Qualifications received in response to this solicitation, followed immediately by a final selection of the consultant by the Authority. The Authority reserves the right to interview the firms prior to final selection, if deemed appropriate.

SUBMISSION REQUIREMENTS:

Each submission shall include a Statement of Qualifications that provides detailed information in response to the evaluation criteria set forth below and include Architect/Engineer & Related Services questionnaires SF 330 (<u>www.gsa.gov/portal/forms/download/116486</u>) with the appropriate number of Part IIs. M/WBE certification of the prime and subconsultants shall be current at the time of submittal and the Consultant shall provide a copy of the M/WBE certification letter from the MassUCP for DBE, within its submittal.

All individuals responsible for technical disciplines shall, upon commencement of the project, be registered Architects or Engineers, in that discipline, in the Commonwealth of Massachusetts.

The Consultant shall specify in its cover letter that it has the ability to obtain requisite insurance coverage.

The Authority may reject any application if any of the required information is not provided: Cover Letter, Insurance Requirements and SF330 Part IIs for the Prime and every sub-consultant. Make sure that the Cover Letter is signed "Under the pains and penalties of perjury", and that you mention the Insurance in the Cover Letter itself.
